

EXECUTIVE DIRECTOR'S REPORT By Joel Jackson, CGCS

1. Government Legislative/Regulatory Update
Legislative Report: Mark Kann, Ralph Dain and I,
accompanied by Erin Boyd Wilder of Sod Solutions met
with Mr. Pete Mitchell, Chief of Staff for Senator Bill Nelson
for nearly an hour advocating on the issues of NPDES, H2B Visa Workers and Federal Disaster Relief for Golf
Courses on September 9th. I feel we made a positive
impression and certainly made Mr. Mitchell aware of how
environmentally proactive golf course superintendents are.

NNC: EPA has granted Florida some leeway in lowering impairment values for Class III waters, mainly canal systems which are not "natural" bodies of water. FDEP is also applying to EPA to designate tidal waters also a unique class with variable values due to changing salinity concentrations.

At the recent FDEP Nutrient Criteria Workshop (October 4th in Naples) Maps and tables of Total N, Total P, Chlorophyl A and Dissolved Oxygen for estuaries from Tampa Bay all the way to Biscayne Bay, Florida Bay and the Keys was presented. Methodology and values were discussed. Seagrass beds are being used as a signal species indicator as to the overall health of each system. They showed annual variations due to events like the strong El Nino in 1997, and the impacts of the 2004 Hurricane season.

The word fertilizer was not mentioned by FDEP or any stakeholders. Nutrients (leaf litter mentioned often) some references or questions about septic tanks, treatment plants, but no direct fertilizer causes were really discussed in depth, Color, Turbidity. Anthropogenic (man made - dredge and fill, seawalls, canals, flood control, etc) factors were also discussed. In some cases areas cannot be restored to pre-existing conditions because of physical alterations.

FDEP and the Estuary Consultant constantly reminded the activists that they often reduced concerns down to a "nutrient" cause and effect when actual Total N and Total P numbers reflected natural uncontrollable events which were documented. (Treatment plant failures, above normal rainfall periods, droughts, etc. They kept hammering home the point that ecosystems are complex and are restorative by nature when we can identify a specific cause and effect and eliminate the cause if it is in fact practical, feasible or realistically possible. Don't blame "fertilizers, i.e. nutrients" automatically and enact expensive corrective programs, when the extent of any numerical impairment might just be a cycle that passes naturally.

NPDES: Congress continues to pressure EPA to back off

H2-B Workers: Congress has also had some affect the Dept. of Labor's move to make the Visa Worker program so expensive and cumbersome. A joint letter from 42 legislators was sent to the Secretary of Labor calling for canceling the new proposed rules. The deadline appears to have been delayed as several groups have also banded together to bring two lawsuits agains the DOL's new rules, which essentially would shut down the program. The GCSAA is considering supporting the litigation, but will not sign on as a litigant in the suit.

Water Restrictions: Latest bulletin from the SFWMD is that Phase 1 restrictions may stay in place until the fall "dry" season begins, which could be tough for some courses. While aquifer and reservoir levels have improved they are not in a comfort zone for the lifting of the restrictions.

2. Allied Association News: We are in the beginning stages of discussions with our Florida Allied Golf Associations to participate in the 2012 Florida Golf Day in Tallahassee on February 14th. This group will also help us in getting in to see particular legislators for any issue we feel needs discussion with a particular House or Senate committee chairman. I have information from the Georgia GCSA about what they did for their part of the Georgia Golf Day last year to give us some ideas and a starting point.



GCSAA Field Representative Ralph Dain, Erin Boyd Wilder of Sod Solutions and FGCSA President Mark Kann along with FGCSA Executive Director held an hour-long meeting with U.S. Senator Bill Nelson's Chief of Staff, Peter Mitchell in Tallahassee in late September on Golf, Turf and Labor issues.

The Fall 2011 Board Meeting of the FGCSA Board of Directors was called to order by President Mark Kann at 1:51pm, October 14, 2011 at the University of Florida Plant research and Education Unit.

All officers except Gary Myers, CGCS, past President were present. All Chapters were represented, with the exception of the Ridge chapter. The Chapter Representatives were: Calusa, James Foster, CGCS; Central Florida, Rickey Craig; South Florida Ricky Reeves; Everglades, Bill Davidson, CGCS; Treasure Coast, Carlos Arraya; Seven Rivers, Jim Shaffer; West Coast, Trent Inman; North Florida, Brad Smith; Suncoast, Darden Nicks; Palm Beach, Brian Main.

Others attending the meeting were: Jennifer Bryan - Association Manager; Joel Jackson - FGCSA Executive Director; Ralph Dain - GCSAA, and Todd Lowe - USGA.

Minutes of the FGCSA Summer 2011 Board Meeting were approved.

USGA Update – Todd Lowe reported the USGA continues to enjoy its relationship with the FGCSA; providing education for both the Poa Annua and Crowfoot. The USGA would like to do more and wants to remind the local chapters that both John Foy and Todd are available for chapter education. The USGA is bringing back the Course Official Meeting; comprised of the superintendent, GM, golf pro and Greens Committee. These discussions have proven to be very successful. Todd also reports that the TAS fees will be going up \$100 in each category.

GCSAA – Ralph Dain reported that the GCSAA has announced the hiring of Richard Konzem as COO. The GCSAA is also in the initial phases of hiring Regional Staff positions for the Southwest, Northeast and Northwest.

Financial Reports – The Secretary/Treasurer submitted his financial report to the Board.

Membership – Trent Inman reported to the Board the current membership numbers. We have nearly reached our budget projection. Please continue to remind chapters to submit late renewals to the FGCSA office so we can keep accurate records.

Publications – The Fall issue of the Florida Green is in production and will go to printer next week. We continue to look for more advertisers and Industry Partners. The FGCSA Membership Directory will go out in January. The ad deadline has been extended to October 28th.

New Business – A motion stating that beginning July 1, 2012 all chapters begin using QuickBooks as their accounting software was moved and approved.

Jennifer will investigate bundled licensing and report what is available for the chapters at the next board meeting. The SOP will also address these changes and those changes will also be addressed at the next board meeting.

Farmlinks – Jennifer will contact Farmlinks to find out available times for our Board to attend and will report back to the board.

The Winter Board meeting will be held on January 20, 2012 at 9am at Hawk's Nest. The meeting was adjourned at 3:15 pm.
