

through emails and conference calls to work on our behalf.

In 2012 the FGCSA rolled out its Golf Course BMP Certification program. While not required by law, this program is intended to strengthen our position as golf course managers to continue using fertilizer, water and pesticides in a responsible manner. In the majority of local fertilizer ordinances passed throughout the state of Florida, golf courses were exempted citing that they must follow the BMPs as laid out in the BMP Manual for Golf Courses. We know that it is just a matter of time until opponents to our industry come back and attack that exemption. It would be easy for them to question the knowledge and commitment of golf course superintendents to follow BMPs. By running our own education and certification program we can demonstrate our commitment to the environment and responsible use of resources. However, this will only work with your participation. It is extremely important that we get our members to buy into the program and achieve their certification. Only by showing a commitment of the majority of golf courses will we be able to strengthen our position. We are pleased to tell you that beginning with the BMP seminar to be held September 25<sup>th</sup> in Naples, we will also offer the GI-BMP exam. GI-BMP certification will be legally required for all commercial fertilizer applicators as of January 1, 2014. This includes any employees who may fertilize the clubhouse lawns or common areas.

As we begin this year I am excited to have the opportunity to serve our industry and members. Neither the board or myself have all the answers, but we have the desire to serve our members to the best of our ability. If you have constructive ideas or are willing to help we would love to hear from you.

## GOVERNMENT RELATIONS REPORT

Thank you to all that have contacted their US House Member and the two US Senators concerning Methyl Bromide. Through your letters and the work Chava McKeel is doing, we have a few House Members backing a letter to the EPA for us to continue to use Methyl Bromide until the stockpile is depleted. Please contact your Representatives if you haven't already done so. There is still a ton of work to be done on this issue.

The local fertilizer ordinances still keep flowing out of the local governments. Most now seem to have blackout provisions in them right from the start. The newest are in Hallandale in Broward County, Jupiter Inlet in Palm Beach County and in St. Lucie a Commissioner wants to talk about more restrictions on the Model Ordinance that the Commission passed just over a year ago. Indian River County is still working through their ordinance and a resolution, hopefully is coming on August 20th. The Indian River Ordinance has a blackout and a 50% slow release provision in it unless you have taken and passed the Green Industries test.

The Government Relations Committee had our first meeting via telephone and our second meeting is at the FTGA Conference and Show on September 10th. All of you are welcome to come to the meeting, but please let me know so I can get you a chair. Each Committee Member of the FGCSA Government Relations Committee will be looking for participants for your local Committees so step up and volunteer.

Money is collected by the fertilizer distributor and sent to EREF on a quarterly basis which makes this an easy way for your club to help.

The Summer 2013 Board Meeting of the FGCSA Board of Directors was called to order by President Nancy Miller at 8:03 am, August 23, 2013 at Southern Dunes Golf Club.

All officers, except Mark Kann were present. All Chapters were represented. The Chapter Representatives were:

Others attending the meeting were: Jennifer Bryan - Association Manager; Joel Jackson - FGCSA Director of Communications; Todd Lowe – USGA. Ralph Dain – GCSAA, Greg Pheneger - FGCSA Government Relations Chairman and Josh Lewis of Morgan Stanley.

Minutes of the FGCSA Spring 2013 Board Meeting were approved.

Morgan Stanley Report – Josh Lewis provided a summary of the FGCSA's Morgan Stanley Account. The account is set up as a tactical portfolio with 70% stocks and 30% cash. It is a model 5 portfolio. No changes to the account were recommended.

Secretary/Treasurer Report – Bill Davidson presented the year-end financials. The financial reports were presented as 3 separate reports; Operation, Publications and a combined summary report. They will be presented this way in the future. Brian Main motioned for the approval of the financials. The financials were approved.

**Benevolent Fund** – Nancy Miller presented a letter to the board for benevolent assistance for Jim Foster. More information will be provided to the Executive Board for review. A motion was made by Brian Main to remove the Benevolent Account form the Operating Account and to create its own bank account with Bank of America. In addition the old signature cards would be removed from the account and replaced with the incoming President's, Kevin Sunderman and Association Manager, Jennifer Bryan. The motion was approved.

### **Committee Reports:**

**Director of Communications** – Joel reported that the Fall issue of the Florida Green is well in the works. He urged that each chapter provide an official "Chapter reporter" who will be responsible for communicating the chapter's activities to Joel. In addition the Florida Green is always in need of Hands on Articles. Andy Neiswender and David Dore-Smith both committed to submitting an article.

#### Government Relations - Greg

Pheneger reported to the Board that the next Government Relations meeting will be on September 10<sup>th</sup> in Orlando during the FTGA. It will include other members of our Allied Associations. The Board is also welcome to attend. Chava McKeel continues to be work with the House and Senate to allow the use of Methyl Bromide in the reserve stockpiles. Greg is still in need of a Government Relations committee member from the Palm Beach and South Florida chapters. It is important that we stay on top of these local ordinances - set up a web check of your local areas to see what is coming up on agendas. EREF has set up the voluntary assessment of fertilizer sales. These proceeds will go toward research. You can sign up for the program from the FTGA website.

**Education**– Jim Shaeffer presented an Education calendar to the Board. Jennifer will make sure to add those items to the website.

**Golf** – The FGCSA Championship had a field of 78 golfers and 7 tee sign sponsors. The event continues to grow and the format and location will be

evaluated by the Golf Committee.

**Membership** – Jennifer presented a membership chart to the board. Membership renewals appear to be steady.

**Research** – Financials for the research account were presented to the board. There were no new proposals presented. The FGCSA did receive some money from the latest auction from Rounds4 Research. This will continue to be an opportunity for the state and chapters to raise money for research. Jim Shaeffer reported that the SRGCSA committed to the second year of the Dr. Kenworthy study in which the FGCSA had funded the first.

GCSAA- The format for the GIS conference and Show will change for this year. Golf will take place Sat, Sun and Monday. Education will occur Mon.-Wed.. The tradeshow will end on Thursday and nothing will be on Friday. The GCSAA's Field Staff program continues to expand. An announcement should be made soon on the new hire for the Southeast Region. This position will be in place by the Chapters Delegates meeting. The deadline to for chapters to RSVP for the Chapter Delegates meeting is September 3<sup>rd</sup>. All chapters need to have a representative. The GCSAA's membership numbers are holding steady - no loss. R4R received donations from 37 courses in Florida. The roll out for the next auction will be reevaluated and may change to the Masters. The GCSAA Chapter Outreach grant deadline is Oct. 11. The deadline for Government Relations nominees is due by October 15th and Environmental Stewardship Award Recipient nominees are due by October 18<sup>th</sup>.

**USGA** – Todd Lowe reported that the USGA is providing a full day of

The FGCSA Annual Board Meeting was adjourned at 10:58 am.




