very excited about this event. We expect both the chapters and the FGCSA to gain valuable information to improve what we provide to our members. Chapter leaders will be receiving more information about this important event.

I want to once again express the importance of signing up to participate in EREF. This coalition of green industries aims to improve our stance when it comes to the significance of properly maintained green spaces including golf courses. You can participate in various ways: the simplestis by visiting Floridagesa.com and clicking on the EREF tab. There you can sign up to participate in a check-off program of sorts where you pay a voluntary 0.6% donation on all fertilizer purchases to be collected by the billing distributors through yourinvoices. This amounts to a mere \$6 per \$1000 spent. This money is being used to strengthen our position including advocacy efforts towards government officials and the general

public. If everybody gives a little we can achieve a lot.

If you have not yet participated in the Golf BMP Certification program I encourage you to do so at the next opportunity. It is important that we, as golf course superintendents, demonstrate our dedication to preserving the environment and water quality. We need a majority of our members to successfully complete this certification. In doing so, we can communicate to lawmakers and the public that we are not part of the problem but rather the solution when it comes to environmental concerns. Last decade our leaders had the foresight to create the BMP for Golf manual. Many times over the past several years local fertilizer ordinances have cited this manual as law for golf courses to follow. In doing so, golf courses were exempted from the more stringent rules demanding summer blackout periods for nitrogen and phosphorus applications. It is reasonable to say that without the BMP manual for Golf there would be no exemption. We feel that the FGCSA BMP Certification program may have the same effect in the future as opposition continues to look for increased legislation against fertilizer, pesticide and water usage. We need your participation to strengthen our reputation as stewards for the environment and to increase our chances of being allowed to manage our facilities using all of our available resources.

Thank you for your involvement and I look forward to hearing your ideas and feedback

The local fertilizer ordinances are still rolling along. There is not a part of the State of Florida that has not had one passed or soon will have one up for consideration. Please get out and visit your local officials as soon as possible. Don't wait for the matter to come up before the council because by that time their minds are already made. The Government Relations Committee can help email you handouts for you to give out and the handouts give you points to talk about. Please make this a priority.

Chava McKeel, the Associate Director of Government Relations for GCSAA, is still working on extending the deadline for golf's usage of methyl bromide. Chava has changed tactics just a bit and is concentrating on gaining the extension for the Southeast since most of the usage occurs in that area. Chava gave us a short survey that was then passed on to those superintendents that had renovated greens and did or did not use methyl bromide. The survey was also done in Florida, South and North Carolina and Georgia.

Ralph Dain was a huge help in contacting Superintendents that he knew had done renovations and in less than a week members of the FGCSA returned 38 surveys for Chava to take to the EPA. The EPA metioned to Chava they were very impressed with the quick turnaround and the thoroughness of the survey. Thank you to all that participated.

We need your help because now we are now missing three chapter representatives on the Government Relations Committee with the relocation of Bob Coffey to the Bradenton area. Bob was a great committee member and will be missed. We need representatives from the Palm Beach, South Florida and now the North Florida Chapters. Please someone step up to the plate and volunteer.

## COMMUNICATIONS REPORT By Editor, Joel Jackson, CGCS Retired



#### Lloyd Clifton, ASGCA Fellow, Dies at 89

BROOKFIELD, Wis. – Lloyd M Clifton, Sr. a Fellow of the American Society of Golf Course Architects (ASGCA) and a founding member of the design firm Clifton, Ezell, Clifton Golf Design Group (CEC Design Group), died Dec. 10, 2013. He was 89.

Clifton worked with fellow ASGCA member Kenny Ezell, and his son, ASGCA member George Clifton, at the firm, which has offices based in Deland, Fla. and Wildwood, Fla.

Clifton and his firm are perhaps best known for their design work and master planning at The Villages--which has grown from a 9-hole Bahia golf course when it opened in the late 1970's to the largest golf community in the world—a retirement community in Central Florida which CEC Golf Design has developed 603 of the 630 holes planned.

Cliftons's layouts included Grey Oaks, Naples, Fla: Hunters Creek, Orlando, Fla.; Highland Creek, Charlotte, N.C.; Debary Plantation, Debary, Fla. and Plantation Bay, Ormond Beach, Fla.

A standout high school football and baseball player, Clifton played both sports at Stetson University, and advanced to playing semiprofessional ball in Florida. Knee injuries kept him from pursuing a career in sports, however, and he enrolled in the horticulture program at the University of Florida. He began his involvement in golf as the golf course superintendent with the City of Daytona Beach's municipal courses. A move to Orlando as a construction/golf superintendent at Rio Pinar Golf Club in 1957 opened the door to his start in golf design.

Clifton's background as an agronomy consultant led to his involvement in more than 150 golf course projects over the years. He was one of the first recipients of the Florida Turfgrass Association's "Wreath of Grass" award in 1961. His first course West Orange CC was completed in 1964 and he designed 16 others before forming Lloyd Clifton and Associates with George and Ken in 1987, which soon became Clifton Ezell Clifton (CEC).

Clifton was elected an Associate member of ASGCA in 1993, a Regular member in 1995 and became a Fellow in 2000. Clifton is survived by his wife of 65 years Bonnie Jean, his sons Lloyd Jr. (Clif), George, and Craig, their wives, 6 grandchildren and 5 great grandchildren.
