The National Turf Conference and Show sponsored by the National Greenkeeping Superintendents Asosciation will be held at the Hotel Sherman, Chicago, January 29-February 2. The educational program is scheduled for Wednesday and Thursday, January 31 and February 1. The usual interesting and valuable program has been arranged. This is a meeting all of us would like to attend. How many will go is the question? This matter should be discussed at our January meeting and some one should be prepared with facts and figures on the minimum cost of such a trip. How about you Phil Cassidy?

Now the Changes In The By-Laws. Various recommended changes were approved at the meeting and according to our by-laws these changes must lay over until the January 8 meeting for a two thirds vote and the changes published in this Newsletter. Here they are:

- Approved.—Bring up to date the list of our club presidents. Explanation. The last president listed was 1939.
- Approved. Incorporate under history of the club the fact that we as a club was instrumental in bringing the National Turf Conference to Boston in 1950.
- Approved. The name of our club be changed to "New England Greenkeeping Superintendents Association" Explanation. Some may wish to discuss this further at the January 8 meeting. You said it and ye editor is one.
- 4. Approved. Change the wording under article III paragraph (f) and entirely eliminate paragraph (g) of this same article. Explanation. Under paragraph (f) eliminate "after January 1, 1939" and eliminate, "shall automatically cease to be" and in the place of the latter these words, "may be dropped as".
- 5. Approved. Add a new paragraph to article IV stating, "Anyone who has been a member of this club in good standing for 30 years shall be exempt from membership dues and shall be entitled to full membership privileges". Explanation. Think this one over too.
- 6. Approved. Under article V eliminate paragraph (b) entirely, and change paragraph (a) to read, "The annual Membership dues shall be ten (\$10.00) dollars payable in advance. New members shall be required to pay an initiation fee of ten (\$10.00) dollars."
- 7. Approved. Under article VII paragraph (b) a change in the title of Entertainment Committee to "Educational Committee" and words to the effect, "That the golf and educational committee chairman shall each appoint two other members for their committees". Later in this same paragraph (b) eliminate the words, "Educational and Inter-relations committees of six". Add to this same paragraph the words, "and a publicity committee of three".
- 8. Approved. Under article VIII, paragraph (h) change the word Entertainment to "Educational". Under paragraph (i) of this same article eliminate the last sentence.

That's all gentlemen. It must be clear as mud to you now, particularly to those who were absent at the last meeting. Be sure to attend the January meeting. Bring your copy of the by-laws with you.

Don't forget, the next meeting will be held at the Waltham Field Station, Monday, January 8, at 12:30. We'll be seeing you.
