The feature at this meeting, shown for the first time was the Westpoints New Aeri-Dryer. A power machine to remove surplus water from the greens. Somewhat similar in general appearance to the Verti-cut it consists of a highly absorbent roller, a metal squeezing roller, and a non-clogging pump. In addition to operating over the greens to remove surface moisture it can work from a stationary position to quickly and easily drain puddles of water from greens and traps.
