Highlights of the National Turf Show were:

Unions on the golf course — Will eventual high labor costs price clubs out of existence?

Percentage of sand and particle size of same in topdress mixtures and soils.

Do Urea-Form fertilizers do what they are supposed to do?

Locally, we discussed possible holding of the National Turf Conference in Boston in 1961 and increasing our representation in the National Association before that time.

There is serious concern by Superintendents on the use of the deeply corrugated saw-tooth type rubber soled shoes used by an increasing number of golfers. They have no place on the golf course it is felt. The Committee has contacted Alexander M. Radko, Eastern Director of the U. S. Golf Association for suggestions or a possible ruling banning this type of footwear from putting greens in particular. Mr. Radko has forwarded our comments to Joe Dey for consideration.

Our March meeting will start with lunch at 12:30 noon, Monday, March 3, 1958 at the Waltham Field Station. An engineer from the Briggs and Stratton Company will answer pertinent questions concerning the light weight engines now in use.

The International Chemical Company will present a film showing the mining of phosphate in Florida and the mining of potash in New Mexico.

Tony Sperandio will show a composite film of some of our past outdoor meetings. This is a chance to look back and think ahead.
