The By-law revision committee was disappointed that membership in the National Association was not made compulsory for regular members. The committee does feel, however, that sentiment expressed during discussion indicates National membership will be mandatory in the very near future. A committee of William Ash, Narry Sperandio, Philip Cassidy and Michael O'Grady was appointed to draw up an appropriate letter on the matter of the ripple sole type of shoe report by the U.S. Golf Association.

The feeling of the Golf Course Superintendents Association of New England is that the report was premature and inconclusive. It was pointed out that the findings were not in agreement with a report in the Autumn, 1948 Journal of the U.S.G.A. No one argues with the comfort of this type of footwear. The one specific objection to the ripple type sole is that it disturbs the grass of the putting surface to the extent that the surface is not smooth, remains uneven for an extended period, and leaves markings and indentations obvious to even the most casual golfer.

Several Country clubs have banned this type shoe from the course. One club has even incorporated this ban in their By-laws.

Our Association has received a letter from the N. E. Professional Golfers Association stating their definite objections to this type sole shoe on the putting areas.
