# PRESIDENT'S MESSAGE

#### **PUBLIC RELATIONS**

United States business spends \$2 billion a year on public relations or PR as it is known in the industry.

Just what is PR? Robert Heilbroner calls it the business of the Invisible Sell or Dale Carnegie called it, the professional winning of friends and influencing people, not for oneself but for one's company or client.

The first practitioner of public relations was P. T. Barnum.

Good PR serves as a conscience for many companies to help speed up communications and help management to become more aware of public opinion and to respond to it.

It is then obvious, when a statement is released to the press regarding course conditions, it should come from the Superintendent.

I think we all agree that the Golf Course Superintendent is the Major-Domo of the golf course. Therefore, he should be their PR man. He knows all the intimate little details of it's construction, condition, etc.

The Superintendent is a club representative and his every day deportment with club members and people of his community reflect good or bad public relations.

A code of ethics does not make a professional, but a Superintendent's actions and conduct does.

### WHAT IS THE GOLF COURSE SUPERINTENDENT'S FUTURE?

It seems as each year goes by that there are new advances in turf management making our job more technical and complex. This is progress and the way it should be. The demands of the game are greater, the members expect more for their dollar. Up to a few years ago a member expected only good tees and greens, now the fairway and rough have to be lush too, the fairway cut at almost putting green height. A number of clubs in our area have had to go into a fungicide spraying program on the fairways. Cutting fairways at between 1/2 and 3/4 inches or less is requiring more water, fertilizer, and a program almost as demanding as taking care of the greens. Where will this all end?

Fortunately our equipment manufacturers, irrigation consultants, schools and universities are taking large strides to try to help the Superintendent. The Superintendent also has played a large part in the innovation of new equipment.

A number of years ago, such items as the topdresser, matting machine, automatic irrigation system, growth inhibitors were unheard of. All of these new items can be within the reach of the Superintendent now. The advances within the past ten years have been phenominal. The new machines and technical knowledge can save a club thousands of dollars in labor costs, which is the major percentage of a golf course budget, with good labor getting harder to find and keep.

An example of a new item to come out this year is a soil acidity tester — it can test PH in seconds. I am not trying to push this product, but it is a step in the right direction. When you send in soil samples to be tested at a University or fertilizer dealer, you make a composit of soil in different areas of the fairway — a wet area will have a different PH than a high and dry area. It sometimes takes weeks to get the results back. This tester can tell you in seconds what the PH is.

It may sound far out, but some day you may have a guage in every green, tee, and fairway to tell you what the needs of the grass are at a given time — moisture, fertility, PH, what fungi might be active at that one time. I am not saying that the Superintendent could be replaced by a computer, but we must keep up to date on the advancements in our profession. We must keep up to date by attending and supporting our

local and national association, by attending all conferences. These are for our benefit.

As our profession does advance and become more technical, perhaps we should help our members see that this change is taking place. The clubs that I am familiar with are demanding more intensive care on the entire course; however, they are not interested in the Superintendent's problems in providing this extra "grooming" on the course. In order to receive budgets adequate to maintain the course in the manner the members want, and respect and credit for our professional knowledge; perhaps it should be part of our job to help them realize the importance and complexity of our job. That we are a major part of the "professional" team pro, manager, Superintendent - that keeps their club operating. We are not just hired gardeners and should not be treated as such. How many of you have made a decision regarding the maintenance of your course based on your knowledge and experience in this field only to have your plans thwarted by a member who insists that it must be done his way although he has no understanding of the situation? We are the ones who must rectify this situation. We have advanced beyond the age of the man with a green thumb taking care of a golf course, from Greenskeeper to Golf Course Superintendent and beyond.
