The educational features were excellent, and we can't help but believe that the clubs who were farsighted enough to send their superintendents will be repaid with better turf in 1954. The following brief examples from some of the talks have application in the West for increased golfer satisfaction.

Enjoyable Wait on Tees -- Michigan

Andrew Bertoni, Golf Course Superintendent, Meadowbrook, C.C., Northville, Mich. sinks a few putting cups on what would otherwise be non-usable teeing space. This is done on the few tees where play tends to stack up, and quite naturally makes the delay more enjoyable while giving the players a chance to sharpen their game. It further implies that the tees at Meadowbrook are clipped at or near putting green height. The Green Section concurs with Andy that this should be done anyway from the standpoint of a firm stance, less divots and more rapid healing.

Early Season Neglect Causes Mid-Summer Problems -- Wisconsin

A perennial favorite, Agronomist O. J. Noer, Milwaukee Sewerage Commission, emphasized that many clubs start the season with too small a labor force. This means early season neglect of special maintenance practices like aeration and thatch removal. Such neglect can lead to loss of turfgrass during critical summer periods. The answer lies in careful planning to assure each superintendent the needed manpower during the spring season when such jobs should be done.

Little Things Count -- Florida

Frank Goodwin, Professor of Marketing, University of Florida, pointed out that there will never be a formula available for dealing in human relations, and that we should never underestimate the importance of the little things that count. In fact, Professor Goodwin never discusses labor relations, because they are inseparable from human relations. If we are enthusiastic, friendly and cheerful in dealing with our fellow man it becomes as contagious as the measles, and so called labor problems will in the main disappear. Three important points worthwhile remembering were brought out in Frank Goodwin's talk. They are as follows:

- 1. Remember Names
- 2. Smile
- 3. Speak the Fellows Language
