



## President's Message

I have had several people work for me who later became golf course superintendents. As I look back, I wish I had spent more time with them discussing some of the "other things" superintendents need to know. Here are a few of the "other things".

- Dealing with members, owners and golf professionals.
- Dealing with salespeople, contractors and inspectors.
- Why we buy certain products from certain people.
- Employee motivation.
- The importance of good clear communication.
- Processing paperwork.
- Applying for a superintendent position.
- Negotiating salaries, benefits, privileges, and association expenses and dues.
- Responsibilities and time devoted to the job.
- Writing and balancing budgets.
- The working superintendent versus the managing superintendent.
- Explaining honest mistakes.
- Supporting scholarship and research funding efforts.

An untold number of assistant superintendents with an excellent understanding of mechanics, turf requirements, and scheduling labor have had difficulty with the "other things" when they became superintendents.

If you have an assistant that you feel has superintendent potential you can help him and the golf industry by discussing "other things" with him as soon as possible.

You can also help by introducing him to the superintendent "community." Encourage him to join the FGCSA and attend a few chapter meetings each year. This invaluable experience can assure your assistant that we all have similar problems and that we are prepared to help our fellow members upon request.

## BENT II SEMINAR

The FGCSA Education Committee presented a highly successful Bentgrass Part II seminar at JDM Club on Wednesday, September 7th.

Superintendents and club officials totally 93 attendees were treated to an informal question and answer type discussion of all phases of Bentgrass maintenance.

Panelists included Dr. Paul Alexander, Dr. James Beard, Dr. Joseph Duich, Dr. Bruce Martin and Dr. Joseph Vargas. Panelists agreed they gained as much information from our Florida superintendents to aid them with their research as the superintendents gained from the experts concerning their particular problems with maintaining their greens.

The program was videotaped by David Court and is currently being edited onto one tape. A survey will be sent to all attendees to get their feedback on the program. The Education Committee is planning another seminar for the same time next year but a specific topic has not been selected pending review of the surveys.

## BIG DOLLARS DONATED FOR RESEARCH

The combined efforts of all local chapters of the FGCSA amounted to a total of \$44,620 being donated to the FTGA Research Foundation on Tuesday, October 11, 1988, at the FTGA Awards Banquet.

Specific chapter contributions were as follows:

Treasure Coast	\$ 1,120.
West Coast	\$ 6,500.

Most of the chapters raised their funds through Golf Tournaments planned by the local chapters. We applaud the efforts of the local chapter officers and Tournament Directors who elected to give their time in setting up and running these very successful events. Chapter members are also to be congratulated for pitching in and supporting their chapter tournaments.



The Ridge is in a gray area which touches several other associations with no particular association having an over-riding influence. When one considers distance and local needs, it is easy to understand why a local chapter is so important.

The next meeting of "The Ridge" will be in the first week of November, I will be attending this meeting on behalf of the FGCSA and will be prepared to offer any help they may request.

All of the local state chapters have volunteered information on their respective chapters concerning their set-up and the guidelines they use to operate. This information will go a long way in helping this group get rolling. I will be reporting in future issues as to the progress of this group.

## EXCERPTS

The 1988 FGCSA Tampa Board Meeting was held on Saturday, October 8, 1988, in the Hyatt Regency Hotel, Tampa. The meeting was called to order by President, Cecil Johnston at 1:00 p.m.

All Officers and External Vice Presidents were present except for Gulf Coast chapter.

**GCSAA Conference and Show:** Randy Nichols, GCSAA 1990 Conference and Show Committee Chairman, gave a report on the 1990 Convention which will be held in Orlando. Registration is expected to be approximately 13,000 with 375,000 square feet allotted to the Trade Show area. The GCSAA will provide 35 seminars and the Peabody Hotel will be the headquarters hotel.

Mike Perham, FGCSA Chairman of the 1989 and 1990 Conferences, gave a report on his committees progress. We will have our FGCSA booth setup at both Shows. Mike suggested that members' wives may be available to man the booth when conflicts occur. Bonnie Stevenson is the GCSAA Show Coordinator.

**It was decided that the FGCSA would give something away at the Anaheim show (such as a bag tag) that would serve as advertisement for the Orlando show and then we might consider a larger giveaway item at the Orlando show.** Dan Jones would like to print an extra Commemorative Issue of the Florida Green that would be sent to Early Bird Registrants only. Janet Rose, GCSAA Membership Chairman, estimated that 1,500 superintendents would take advantage of Early Bird Registration. National advertisers and local Orlando tourist attractions and restaurants would be approached to advertise in this special issue in order to offset the cost involved. **The issue would not be sent to the regular Florida Green mailing list — only to those who are actually attending the Conference.**

Mike Perham suggested that we make some arrangements with the Orlando airport to have a Welcome Center or at least a banner prominently displayed as travelers come in for the show.

Randy Nichols distributed the "Guidelines for host chapters during the GCSAA Golf Championships" which outlines the duties expected of us as the host chapter. Joe Ondo and Steve

Wright are contacting local Orlando golf courses that would accept GCSAA members on their courses during convention days. This list will be distributed at the FGCSA booth and would be included in the special issue of the Florida Green.

The host chapter usually sponsors a cocktail reception on the night before the tournament for 400-500 people. It is permissible for the host chapter to get sponsors for this reception but we must be certain that they are listed as supporting the FGCSA and not the GCSAA since the GCSAA maintains sole proprietary sponsorship of the GCSAA Championship and Tournament. The same guidelines applies for soliciting tee prizes.

Cecil Johnston will contact Betsy Evans, Coordinator of the Spouse Program, to offer our help with forming the spouse program.

**Green Sheet:** Mike Bailey reported that Estech will continue to support the newly enhanced format of the Green Sheet for the next two issues.

**Membership Directory:** Marie Roberts reported that most chapters have sent in their dues lists for the Directory but that there is still room for more advertisers.

**Supplier Members:** Ray Hansen again brought up the question of allowing suppliers to join the state association. It was decided that Mike Bailey should include a question on this in his survey that he has compiled.

**Education:** Tom Burrows reported that since the POA seminar in May, 340 individuals have attended seminars presented by the FGCSA. He outlined the different seminars that have been proposed for the next year starting with an Irrigation seminar slated for January, a Mechanics seminar proposed for Lake City Community College in May, a Chemical Seminar proposed for June and another type of seminar to be held in the Palm Beach area again next September. The Education Committee will get together the material for the Irrigation seminar and the Chemical seminar and present it to each local chapter asking for a guarantee of an audience if it were to be presented at their local chapter meeting time. If a chapter can guarantee a certain number of attendees, then the Education Committee will go ahead with the planning of the proposed seminar.

The proposed Mechanics seminar has been scheduled for May at Lake City. It will be a two day seminar with a limit of 25 mechanics on a first come, first serve basis. The Education Committee will look into the possibility of providing transportation to and from Lake City as a part of the registration fee. If the course is successful, it will be repeated toward the end of the summer.

**By Laws:** Mark Henderson proposed a change in *Article IV, Section 2*, which states that dues must be paid "in advance" for the fiscal year. He proposes that we eliminate the words "in advance".

**Fund Raising:** Joel Jackson reported that this year's Florida Golf Week raised only \$3,500. Next year we will move the date to sometime in March so that more club members can participate in this event. FGW is intended as a public relations effort for the superintendent and his club members and is not intended to be a major fund raising event. A more effective fund raising tool is to have a line item for research in the club maintenance budget. More superintendents are encouraged to include this in their next budget request.

The most successful fund raising effort occurs when the local chapter holds a large golf tournament with all funds going directly to research. It is through these efforts that a total of \$44,620 has been raised by our local chapters. (See article in this issue of the Green Sheet for detailed list of chapter donations).

**Distribution of Funds:** These funds will be presented to the FTGA at the Awards Banquet on Tuesday. Several chapters had specific desires for their funds, such as the Palm Beach chapter and the south Florida chapter. South Florida has contacted Bob Yount of the FTGA Research Foundation regarding putting their \$13,000 raised by the south Florida Exposition into a special account that could be available for a particular project — a USGA green in the south Florida that would be available for on-going research projects. IFAS is willing to submit a formal proposal to the appropriate organization requesting a long-term funding commitment for product evaluation. After much discussion a motion was made to **"Donate all research funds collected by state and local chapters to**

**the FTGA General Fund. Specific distribution of funds can be determined by the individual chapters."** The motion was approved.

A motion was also made that we would **"Request \$500 or more from each local chapter to be donated to the GCSAA Scholarship and Research Foundation. These funds are to be donated through the state association."** The motion was approved.

**Membership:** Tom Benefield reported that the "Ridge Association" held their initial planning meeting with 16 clubs represented. They have planned a follow-up meeting for November. He feels that they are very interested and sincere in their desire to become a chapter of the state association with as many as 20 or 30 members.

**Government Regulations:** Cecil Johnston will send a letter to all Florida Water Management Districts requesting changes in their water shortage requirements.

**Golf:** Joe Ondo reported that the FGCSA golf team for this year will be composed of Mark Henderson, Joe Ondo, Scott Zakany and Dave Oliver. He requested that any other member who has a confirmed reservation for the tournament contact him about the possibility of forming a second team.

**New Business:** The Robert Trent Jones Foundation has requested our input as to the ten courses in our area that not only play well but can be maintained as they were designed. Cecil requested Board members to list their selection and we will pass this on as requested.

**Voting Delegate:** Cecil Johnston will be sending each chapter a letter listing their members who are not listed as voting with the FGCSA so that they may fill out an affidavit in time for this year's election. If any member is willing to serve as Alternate Delegate, please call Cecil.

**Survey:** Mike Bailey submitted the survey he has compiled to be sent to all members within the next month.

**Decal:** Mike Bailey reported that he has received a quote for supplying decals to our members. The Boards would like to see decals be sent if the budget permits.

The meeting was adjourned at 5:45 p.m.

# '88 FTGA CONFERENCE & SHOW

The 1988 FTGA Conference and Show was held at the Curtis Hixon Convention Center in Tampa from October 9-12. With the weather man cooperating this year, registration was at an all time high.

The Show area was packed with exhibitors vying for every available inch of floor space. All space was sold out weeks before the Conference began.

The high point of the very successful Conference for most superintendents was the half day workshops that were held at the Convention Center. University of Florida personnel presented these short courses for GCSAA credit as well as DACS credit. From a quick scanning of the critiques filled out by workshop attendees, the course material and instructors were first rate!



As we move from summer to fall, the mole cricket problems do not go away, and, as we approach fall, worms can attack at a moment's notice. Here are a few tips on some control ideas that I have seen work and are cost effective. The new feeding stimulants such as Entice and Coax are giving excellent results when mixed with Orthene, Baygon WP, or Dursban WP. They also serve to lower the pH of the mix and act as a UV light screen to enhance the residual of the toxicant. The rates of these products make it a very affordable add-in to your tank mix. Also, there is a product that contains its own attractant, Sevimol. The crucial thing with bait is oil moisture and lunar phase. Yes, the moon, I have personally witnessed that mole cricket kill is enhanced by an application during a full moon. If the sky is clear, the light brings up crickets by the thousands. Remember with bait keep the water off for 24 to 48 hours if possible. Good Hunting. ■
