As the days begin to get longer, the snow starts to melt, and the greens covers are peeled back, we are reminded that the Bear Cup is right around the corner! This year's 7<sup>th</sup> Annual Bear Cup, in honor of the late Gary Luccini, will be contested on Monday, April 29 at South Shore Country Club (SSCC). I had an opportunity to speak with host Superintendent, Jay McGrail regarding his history in and out of the business, along with some interesting background on SSCC.

Jay's path to being a successful Superintendent can be categorized as being both familiar and unique. Jay got his feet wet in the business at an early age, however, not on a grounds crew. His first job, as a teenager, was in the cart barn at Old Barnstable Fairgrounds, where a course had just been built. His boss, The Head Golf Professional quickly recognized Jay's

work ethic and dedication when he said to Jay, "A job on the grounds crew might be a better fit for you." From there, Jay set out to become a Golf Course Superintendent.

Upon graduating from high school, Jay enrolled at Stockbridge School of Agriculture, interning at Oyster Harbors Golf Club for long time Superintendent, Jack Nugnes. After graduating from Stockbridge in 1999, Jay received his Bachelor's Degree at UMass Amherst. While at UMass, Jay worked on weekends at Hickory Ridge Golf Club. Once graduated, Jay earned his first Assistant Superintendent job at Nantucket Island's Miacomet Golf Course.

It was at Miacomet where Jay met Charlie Passios, CGCS, and the man responsible for Miacomet's ambitious project of adding a second 9 holes to the layout. Not only did Jay get the experience that came with the project, but he cultivated such a relationship with Charlie that he was asked to follow Charlie in his next endeavor, which was to build The Golf Club of Cape Cod. In 2006, when The Golf Club of Cape Cod opened, Jay left Charlie and his management company for SSCC to fulfill his goal of becoming a Head Golf Course Superintendent.

At SSCC, Jay holds the title of Director of Operations, and, in that roll, is an employee of the Town of Hingham. He attributes much of the grounds department's success to Jake Silva, the Course Superintendent, who handles what Jay calls, "the heavy lifting" and "day to day operations". Jay also holds a seat on the Board of Directors for the Golf Course Superintendents Association of Cape Cod, where he is the Golf Chairman. He is thrilled to be having the 2013 Bear Cup, the first Association event held at SSCC.

The host course is a Wayne Stiles design, opened in 1922. The course was private until the mid 1980's when it was purchased by the Town of Hingham. Jay describes it at a typical Stiles design, with many elevated greens and blind shots. The club is in the middle of bunker renovations, trying to restore the bunkers to their original design. As a public course, SSCC absorbs about 50,000 rounds per year, which, as you can imagine, provides unique challenges to Jay, Jake, and the crew. Regardless, Jay considers SSCC "the best public fee course around."

Away from the golf course, Jay has his hands full with four women in the house. His wife Tarja and he have three daughters; 7 year old Emily, 4 year old Caitlin, and the newest member of the McGrail family, 5 month old Allison. While Jay enjoys playing golf, he is also an avid skier, going up to Vermont as often as he can.

Jay considers it an honor to host a GCSANE meeting and the 7<sup>th</sup> Annual Bear Cup. With the location of the host course and Jay's involvement in the GCSACC, Jay hopes the event will promote integration between the GCSACC and the GCSANE. Along with the golf course, Jay is excited about the opportunity to showcase some of the other amenities SSCC has to offer. The club has three indoor golf simulators that will be available for use after the meeting. Also, SSCC has a golf bar, called "The Tour", but you will have to attend the meeting to see what that entails.

The April meeting at SSCC is going to be a great opportunity to be a part of the latest happenings in your Association. It will also provide a unique golfing experience, as well as a chance to network with colleagues. So please, email or call Don Hearn to attend the April Meeting, compete in the Bear Cup, and meet Jay McGrail on Monday, April 29, 2013! ❖

## **Thoughts From Your Association Manager**

Once you're in the GHIN system you'll be able to enter your own scores, track your handicap and have your current updated handicap sent to you automatically.

A number of emails have been sent to the general membership in March. If you haven't received them a couple of things could be happening. It could be that I don't have your correct email address or your spam filter isn't allowing the messages to get to your in box. If you didn't receive these emails please let me know and we'll square away what's causing the problem.

I attended a meeting of the New England Interstate Water Pollution Control Commission (NEWEY pick) held in Providence, March 12. The meeting was to review where the commission stands with suggested guidelines for fertilizer use. They are trying to create a document that will address fertilizer applications in a way that makes sense for producers, applicators and regulators. Our industry was well represented and our concerns were expressed. I believe the regulators listened and will be reviewing their suggestions with more information to help make reasonable guidelines for all

users. Kevin Doyle, GCSAA's Regional Representative, attended and presented an excellent written statement detailing how our management of "performance turf" differs from the application of fertilizer to home lawns. If you would like a copy of Kevin's statement let me know and I'll send it to you.



## **Etiquette**

Virtually all of us use cell phones. These devices have evolved from telephones to powerful computers that we can put in our pockets. They've made some things we do a lot easier and others more difficult – like leaving work at work.

One of the most annoying things I've encountered is the rudeness some have displayed while using their cell phone. Have you ever been behind a person at the grocery checkout fumbling for their payment while juggling their phone between their ear and shoulder? How about that rude loudmouth driving you crazy as he or she talks about their busi-



How about the proper use of your phone when meeting with a sales representative? Most superintendents I know request a specific time to meet and discuss business. And representatives build their schedule based on the agreed time. During these times full attention should be given to the business at hand. It's important to be respectful and attentive. Don't put your phone on vibrate and place it on your desk. Keep your phone silent and in your pocket. If you know ahead of time that you may have to answer a call during the time of the meeting, it's important to let the person you're meeting with know this at the beginning.

# What follows are some common sense pointers for using your cell phone.

It's not other people's responsibility to cope with your mobile phone use; it's your responsibility to use your mobile phone inoffensively. Please note that "inoffensively" is not defined by what you expect others to tolerate, but by what others do in fact find offensive. Ignore this principle, and you are sure to be rude.

- Maintain at least a 10-foot zone from anyone while talking on a cell phone.
- Never talk in elevators, libraries, museums, restaurants, cemeteries, theaters, dentist or doctor waiting rooms, places of worship, auditoriums or other enclosed public spaces, such as hospital emergency rooms or buses. And don't have any emotional conversations in public ever.
- Never "multi-task" by making calls while shopping, banking, waiting in line or conducting other personal business.
- Avoid text messaging while you are engaged in an activity or meal with someone else. Text messaging in front of others is the equivalent of whispering behind someone's back. Even though it's a typed message, it's just as bad as chatting with someone who isn't there.
- In a casual restaurant, it's usually considered impolite to both the counter staff and the person on the other end of the line to stop in the middle of a conversation to place an order.
- Whether you use a cell phone or landline <u>always</u> return calls. There are few things that show a lack of respect more than someone who does not return a phone call.
- If a game of phone tag goes on for 4 calls (that is, both parties make 2 calls that go unanswered), it is within the boundaries of proper etiquette to end the game and stop calling. Communication has occurred. In placing 2 calls each, you've both sufficiently said your hellos, and by the voicemails you've left it's clear the call has no urgent purpose. It's the same as running into someone on the street and saying, "Hi, great to see you, I'm in a rush, let's catch up later." No one minds, even if you're not actually in a rush and don't really feel like catching up later, because the other person likely feels the exact same way. ❖

### **Massachusetts to Invest \$2.6M in Golf Courses**

The state is looking to improve operations at Leo J. Martin Memorial Golf Course in Weston and Ponkapoag Golf Course in Canton by hiring new managers, reclaiming golf cart and driving range operations, and purchasing 120 new carts. The plan for Ponkapoag includes reopening nine closed holes at the 36-hole course, continuing drainage improvements, and starting an irrigation project this spring.

The state of Massachusetts is spending \$2.6 million to improve operations at Leo J. Martin Memorial Golf Course in Weston, Mass., and also at Canton, Mass.'s Ponkapoag Golf Course, where it hopes one day to host a major pro tournament, the *Boston Herald* reported.

The Department of Conservation and Recreation's (DCR) plan for Ponkapoag includes reopening nine closed holes at the 36-hole course, plus drainage improvements already under way and an irrigation project that is slated to start this spring, the *Herald* reported.

Conditions at the courses haven't always been the best, said DCR Commissioner Ed Lambert, but the state has hired new managers, reclaimed golf cart and driving range operations from private vendors, and purchased 120 new carts, the *Herald* reported.

"Now we'll be making the profit and putting it back into the operation," Lambert said. "It will be used to pay some of the investment in staff and capital that allows us to raise even more money." Golfers, fees will remain at current levels and cart rentals will cost less. Both courses will also start accepting reserved starting times for Friday through Sunday and holidays, the *Herald* reported.

The 77-year-old Donald Ross-designed Ponkapoag and the 18-hole Leo J. Martin course, which opened in 1930, are "great old establishment courses that people always have been passionate about," said Joe Sprague, Executive Director of the Massachusetts Golf Association, which promotes amateur golf in the state.

"If they're going to keep the prices the same and have the conditions improve, that's a win-win for golfers," said Sprague.

The improvements follow unsuccessful efforts to privatize the courses in years past. Last year, the legislature agreed to let the DCR keep 80 percent of its revenue, up to \$14 million annually, instead of returning it all to the state's general fund and awaiting a smaller re-appropriation, the *Herald* reported.

"It's really an entrepreneurial way for us to operate, and it reduces costs to taxpayers," Lambert said. "This year we've already increased [the overall DCR] revenue stream from \$1 million to \$2 million."


The DCR scheduled a public hearing for March 6 at Ponkapoag to discuss the proposed changes, the *Herald* reported.

As spring fights its way in, and winter grudgingly gives up its hold, there are some important pieces of information you should take note of before the golf season takes hold of all your time. First, on the advocacy front, the Voluntary Turf Fertilizer Initiative being undertaken by the New England Interstate Water Pollution Control Commission (NEIWPCC) has completed the stakeholder phase of their process. GCSANE

was well represented. GCSAA has been engaged with NEIWPCC and offered the services of the GCSAA members in the region to craft a suitable measure of involvement in the Initiative. As consumers of turf fertilizer, golf is a likely choice for inclusion in the voluntary program. However, the unique needs of maintaining performance turf at high standards are critical to the vitality of the game. These needs were expressed to the Commission, and the desire to engage golf directly at a later date was welcomed. Golf course superintendents continue to be undervalued as environmental stewards, protecting and even improving our water resources through proper turf management. By working with the Commission in this effort, our role and message can be clearly defined.

A special thank you goes out to David Johnson and Don Hearn. They recently represented GCSANE at the Chapter Leader/Chapter Executive Symposium at GCSAA headquarters in Lawrence, Kansas. Twenty six of the ninety-nine affiliated chapters were on hand. An agenda packed with information and opportunities provided them with tools that will hopefully benefit your association. Look for more specifics from your delegation soon.

A quick recap of the Nor'Easter Ski Day is in order as well. On the 20<sup>th</sup> anniversary of the event, invitations were opened up to Chapters all over the northeast. Superintendents from as far away as New Jersey participated, and GCSANE was represented by a few members as well. Thanks go out to Andy Drohen, Chris Cowan, John Bresna-


