#### **Sherwood Moore Collects Deserved Honors**

One after another, the highest tributes organized golf can bestow on one individual keep coming to Sherwood Moore. In a rare testimonial to the quality of the man and his contributions to golf, Met GCSA member Sherwood Moore is being recognized as few before him have.

First, the New York State Turfgrass Association presented its highest honor, The Citation of Merit, to Sherwood A. Moore at its recent November Trade Show in Syracuse, NY. Sherwood is the first golf course superintendent to have been so honored by NYSTA.

Sherwood, retired Golf Course Superintendent at the Winged Foot

Golf Club and a graduate of the Stockbridge School of Agriculture at the University of Massachusetts, has been a golf course superintendent since 1939. He has managed golf courses in New Jersey, New York and Connecticut, including the hosting of two U.S. Open Championships. Throughout his career, Sherwood has been extremely active in professional associations as an attendee, speaker and author. He has conducted experimental and research work at several golf courses and shared that information with fellow members of the various organizations of which he is a member. He has been President of the Golf Course Superintendent Association of America, the New Jersey GCSA and the Metropolitan GCSA. In 1982, the GCSAA presented Sherwood Moore with its highest honor, the Distinguished Service Award. Sherwood has hosted three foreign exchange students over the years.

The plaque presented to Sherwood by the NY State Turfgrass Association sums up his many qualities: Friend, Teacher, Scholar, Gentleman, Leader and Promoter of the Turfgrass Profession. In conjunction with the Citation of Merit, Sherwood was awarded a life membership in NYSTA.

Shortly thereafter, the Metropolitan Golf Association recognized Sherwood's many contributions at its December Annual Meeting and Dinner. Again a plaque was used to convey this message: "For forty-five years of leadership and service to golf, for helping to establish the stature of the golf course superintendent, for the marvelous golf courses he helped to develop, for the many former students who are now outstanding golf course superintendents – these are living testament to Sherwood Moore's lasting contributions to his profession and the game of golf."

And now as this newsletter goes to press, we are advised that the March, 1985 Massachusetts Turf Conference has been dedicated to Sherwood A. Moore. We are all blessed to have lived with and shared parts of a career with this wonderful man.

#### MGA Provides New Met GCSA Handicap Service

Faced with the problem that a segment of its membership was not eligible to acquire an official handicap for Met GCSA, member-guest and other formal tournaments, the Metropolitan Golf Association has graciously offered to provide a service that will resolve all difficulties.

The Met GCSA will be identified as a participating "club" within the MGA system and will exchange scores and handicap information through the office of its Executive Director.

Met GCSA Tournament Chairman Larry Pakkala emphasized that all Class A members should continue to obtain handicaps through the long-standing gratuitous service offered by the MGA at their clubs. This special service is intended primarily for Class B, C, D, L and retired members.

Met GCSA members wishing to subscribe to this new handicap service should send the following information to Executive Director Jim McLoughlin, %Met GCSA, P.O. Box 196, Thornwood, NY 10594: their name, preferred mailing address/telephone number and a listing of each score played with date and the name of the course. If a player does not have a record of scores but wishes to join the handicap service, the member should submit his or her name without scores to the Met GCSA at this time. A member may join the MGA Handicap Service at any time in the year.

The cost of the MGA Handicap Service will be \$8.00 per player per season. Interested members are asked to send a check for this amount (made payable to the Met GCSA) when requesting to join the handicap service. Direct all handicap questions to Executive Director Jim McLoughlin – 914-769-5295.

# Career Counseling Seminars Announced

Met GCSA Executive Director Jim McLoughlin has announced that a series of Career Counseling Seminars will be sponsored by the Chapter this Spring and Fall for Association members.

The nine hour presentation spread over three consecutive early evening sessions will focus on personal management effectiveness; required and desired communications within a club; employment negotiating philosophy and objectives; and past, present and future career planning.

Following the Seminar series, participating members will be able to have their individual work and presentations evaluated within the program's individual career counseling sessions. Complete Seminar information will be mailed to all Met GCSA members this February.

#### McLoughlin Accepts Additional Assignment

Gerard F. Hurley, NCA Executive Director, recently announced that Met GCSA Executive Director Jim McLoughlin had accepted the appointment to serve as Director of Research for the National Club Association.

The NCA has committed to establishing a national education program for golf club Directors and to developing the computer and software capabilities needed to support this and other related projects. Hurley advises, "Jim McLoughlin's experience with the MGA in New York and the GCSAA prepared him well for this important task."

McLoughlin will continue his work with the Met GCSA and feels the two assignments will complement each other in a natural way, "Any educational process designed for club officials must focus upon the indispensable role of the Golf Course Superintendent."

#### **Winter Seminar A Success**

The Met GCSA held its Winter Educational Turfgrass Seminar on January 9th at the Westchester Country Club. Seven speakers addressed a variety of subjects including – personnel management, long range landscape planning and turf disease control.

The speakers combined traditional information with newly acquired data or improved techniques to truly educate the enthusiastic audience of over a hundred Met GCAA members and club officials. Opening speaker Dr. Richard Hurley's "Selecting Grasses for Golf Course Use" stressed seeking out the newest varieties of popular cool season grasses instead of relying on the tried and true blends.

Mr. Frank Dilucia's "The Art of Supervision" was a lively presentation detailing the complexities of personnel management. "A good positive attitude," DiLucia states, "leads to good supervision. Employee motivation, job delegation and open communications were all discussed.

J.A. French Associate's Dr. Raymond Korbobo made particularly good use of slides to illustrate the effects of proper architectural planning on golf courses. Korbobo explained that the benefits of planning tree removal, as well as the planting of their replacements are immeasurable.

Elanco Products representative Mr. Scott Eicher detailed his companies claims concerning the new *Rubigan* and *Cutless*. Mr. Scott Niven, Golf Course Superintendent at the Stanwich Club, followed with a well documented presentation on the effectiveness of the fungicide and the growth regulator when applied to his course.

Mr. Bruce Cadenelli, Golf Course Superintendent at the Hollywood Golf Club, offered an alternative to the boom and T-jet spray outfits via Micromax, a unique spraying concept employed at his course. Micromax allows for a reduced water/chemical ratio, and by use of centrifugal force, produces more uniform droplets, which can be altered to suit the application desired.

Completing the day's agenda was Dr. Houston Couch of Virginia Polytechnic Institute and State University. His talk, "How to Get the Most and the Least from Fungicides" addressed many of the questions that superintendents face. Dr. Couch took factors such as cultural practices, nozzle tip size and pressure, dilution ratios and weather conditions to provide attendees with useful answers on the effectiveness and longevity of several widely used chemicals.
